O'Neill's lawyers said the judge was entitled to decide that the evidence should be released in support of a motion that he be put on probation for eight years and ordered to pay \$150,000 in restitution he will need to pay in civil court.. Last month, it was reported that O'Neill had been placed on probation for a year and a half for failing to pay child support to a former girlfriend, who the judge said was not an adult at the time for which he was cited..
